ADDITIONAL FEES:

IN-HOUSE REGISTRATION FEE

(Paid by 2/10/12): \$250.00 per child (non-refundable) due and payable at time of enrollment in order to hold a place for your child in the class. The tuition account of a current student must be up to date in order to register that student for the next year (*Financial management Policy L#5*). This registration fee covers the costs of testing, workbooks, lab supplies, student insurance, and Diocesan student fees.

After 2/10/12, this fee increases to \$300 per child.

OPEN REGISTRATION FEE:

\$300.00 per child (non-refundable) due and payable at time of enrollment in order to hold a place for your child in the class.

FUNDRAISER FEE:

\$300.00 per family (non-refundable) due in full on August 24, 2012. All families are responsible for selling at least 6 tickets (\$50 each) for our 800 Club drawings before August 27.

CAPITAL IMPROVEMENT FEE:

\$200.00 per family. Paid with your tuition according to the payment plan you have indicated on the Tuition Payment Agreement.
